SCOPE OF WORK

Purchase of renewal licence of the following products:

1) FGT3HD3916801181- Fortigate 300D
2) FGT3HD3916801421 - Fortigate 300D
3) FL200D3A16000297 - FortiAnalyzer 200D

Duration for which the licence is to be renewed: 01.04.2022 to 31.03.2023

Only the renewal licence is to be purchased. The scope of work does not include any services to be provided by the vendor, except the initial service through which the renewal licence is to be made effective - for which no separate payment would be made.

The licence is to be delivered within ten working days of receipt of the work order from DGCIS. The payment shall be made in full after the receipt of the purchase order and activation of licence.

General Terms and Conditions

- 1. The vendor must have <u>servicing outlet in West Bengal</u>.
- 2. <u>Non-Blacklisted certificate</u> need to be submitted (as per Annexure II).
- 3. The contracting Company/Firm/Agency <u>shall not</u> be allowed to transfer, assign, pledge or sub-contract its rights and liabilities under this contract to any other agency without the prior written consent of this Directorate.
- 4. The tenderer will be bound by the details furnished by him/her to this Directorate while submitting the tender or at subsequent stage. In case, any of such documents furnished by him/her is found to be false at any stage, it would be deemed to be a breach of terms of contract making him/her liable for legal action besides termination of contract.
- 5. The contract can be terminated by this Directorate at any time without assigning any reasons after giving a <u>month's notice</u> and the decision of this Directorate shall be final and binding.
- 6. The period of contract will be valid for <u>one year</u> which may be extended for further one year with the consent of both the parties.
- 7. <u>No extra payment</u>, whatsoever, on account of natural calamities or otherwise will be made except what is permitted under this contract.
- 8. No Tools & Plants shall be supplied by this directorate.
- 9. During the continuance of AMC, if the machine becomes obsolete/ unserviceable, then the contract will be terminated in that month itself in which the machines becomes obsolete/unserviceable.
- 10. The successful Company/Firm/Agency shall maintain all statutory registers under the Law. The agency shall produce the same on demand to the concerned authority of this Directorate or any other authority under the Law.
