- 1. The front and back cover of the book should be bound with good quality rexine of black colour.
- 2. The spine and corners of books may be bound with leather.
- 3. Title/Author/Year and Commercial Library should be written with golden colour on spine or on the front cover (where spine of a book is thin).
- 4. One fly leaf (white paper) each should be fixed before the title page and after the last page of each book.
- 5. All the materials which will be used for binding should be good quality and protected from insect and fungi.
- 6. The firmness of the spine of a book and general workmanship should be of good quality.
- 7. The contracting Company/Firm/Agency shall not be allowed to transfer, assign, pledge or sub-contract its rights and liabilities under this contract to any other agency without the prior written consent of this Director.
- 8. The bidder having a registered office in West Bengal may be preferred.
- 9. The bidder shall attach copy of PAN Card.
- 10. The rates mentioned in the financial bid shall be inclusive of all taxes and duties and any other taxes as applicable. Any variation in the above said taxes till the completion of service will also be in the bidder's account.
- 11. The work order will be awarded for the period of 2(two) years from the date of issuing of the work order.
