

From the Table 1 and Figure 1, it is found that HS Codes 27 (Mineral fuels, oils, distillation products, etc.) 71 (Pearls, precious stones, metals, coins, etc.) and 72 (Iron and steel) constituted the top 3 HS Codes in India's exports to the world in June 2021, accounting for about 28% share of the export-value in the month of June 2021.



Figure 2: Mineral fuels, oils, distillation products, etc [HS -27]




Figure 3: Pearls, precious stones, metals, coins, etc [HS -71]




Figure 4: Iron and steel[HS -72]




Figure 5: Organic chemicals[HS -29]





Figure 6: Nuclear reactors, boilers, machinery, etc[HS -84]



From Figure 2 to figure 6 illustrate the trending values of past ten years top 5 commodities from top 15 ITC-HS Codes comprising India's exports share (%) from June 2011 to June 2021

1) Figure 2: Mineral fuels, oils, distillation products, etc (ITC HS CODE -27) :

The month of June -2014 registered the highest share 22%, next highest share 19% was seen in June 2011 & June 2013 and the lowest share 9% in June -2020 due to the pandemic with present share of 13% in June 2021.

2) Figure 3: Pearls, precious stones, metals, coins, etc (ITC HS CODE -71) :

June 2012 registered the highest share 18%, with next highest share 16% in June 2011 with share of 9% in the month of June 2021.

3) Figure 4: Iron and steel (ITC HS CODE - 72):

The month of June 2021 registered the highest share 7%, with the next highest share 6% in June - 2020. The lowest share 2% was registered in June 2015.

4) Figure 5: Organic chemicals(ITC HS CODE - 29):

The maximum share % of this HS-29 (Organic chemicals) was registered in June 2020 with the share of 8%.


5) Figure 6: Nuclear reactors, boilers, machinery, etc. (ITC HS CODE -84):

The highest value share of 7% was registered in June 2019.


Figure 7:Top 15 PC Codes comprising India's Exports in June 2021



From the Table 4 and Figure 7, it is found that PS Codes S6 (petroleum products), G5 (pearl, precs, semipreces stones) and l3 (iron and steel) constituted the top 3 PS Codes in India's Exports from the world in June 2021, accounting for around 25% of the export-value in June 2021.



From the Table 6 and Figure 9, it is observed that HS Codes 27 (Mineral fuels, oils, distillation products, etc), 84 (Nuclear reactors, boilers, machinery, etc) and 85 (Electrical, electronic equipment) constituted the top 3 HS Codes in India's imports from the world in June 2021, accounting for about 48.65% share of the import-value in June - 2021.



(ITC HS CODE -27)




Figure 11: Nuclear reactors, boilers, machinery, etc
(ITC HS CODE -84)




Figure 12: Electrical, electronic equipment (ITC HS CODE -85)




Figure 13: Pearls, precious stones, metals, coins, etc
(ITC HS CODE -71)





Figure 14: Organic chemicals (ITC HS CODE -29)



From Figure 10 to figure 14 we see that

- 1) Figure 10: Mineral fuels, oils, distillation products, etc (ITC HS CODE -27) :

The month of June 2014 registered the highest import share 38.47%, with the next highest share 38.21% in June 2013 and lowest share 25.54% in June 2017.

- 2) Figure 11: Nuclear reactors, boilers, machinery, etc (ITC HS CODE -84):

June 2020 registered the highest share 10.46% and June 2021 (present), the next highest share.

- 3) Figure 12: Electrical, electronic equipment (ITC HS CODE -85):

June 2020 registered the highest share 12.19%, the next highest share 10.03% in June 2019.

- 4) Figure 13: Pearls, precious stones, metals, coins, etc (ITC HS CODE -71):

The highest share 18% was registered in June 2011.


- 5) Figure 14: Organic chemicals (ITC HS CODE - 29):

HS – 29 (Organic chemicals) registered the highest share 6% in June 2020, and the lowest share 3% in June 2011.

Figure 14: Top 15 PC Codes comprising India's Imports in June 2021






