

From the Table 1 and Figure 1, it is observed that Mineral fuels, oils, distillation products, etc. (HSCodes 27), Pearls, precious stones, metals, coins, etc. (HS Codes 71) and Nuclear reactors, boilers, machinery, etc. (HS Codes 84) proved to be the top 3 commodity groups (ITC\_HS 2 digit codes) in India's exports to the world in June2022, accounting for about 39% share of the total export-value in the month of June2022. Almost all the top 15 sectors showed Year on Year (YoY) % increases, Mineral fuels, oils, distillation products, etc (HS code -27) has shown export value increases above 100%. All the other commodities registered YoY increases in export from February 2021 to February 2022, with the exception of Iron and Steel (HS Code-72) and Plastics and articles thereof (HS Code-39) that registered the YoY decline of 34 % and 20 % respectively.







#### Figure from 2 to 6: Five Major Commodities of India's Exports from Top15 ITC-HS Codes








Figure 2: Mineral fuels, oils, distillation products, etc. <u>(ITC HS CODE</u> -27) :

During the month of June 2022 this commodity group recorded the highest share of 26%, with the next highest share of 15 % registered during June 2018 and the third highest share of 13% realized during June 2021. The lowest share of 9% was during June 2020.

#### Figure 3: Pearls, precious stones, metals, coins, etc. (ITC HS CODE -71) :

During the month of June 2018 this commodity group registered the highest share of 13% (i.e.13.0%), with next highest share of 13% (i.e.12.70%) during June 2019 and the third highest share of 9% during June 2021. The lowest share of 7% was during June 2020.


#### Figure 4: Nuclear reactors, boilers, machinery, etc. <u>(ITC HS CODE - 84):</u>

During the month of June 2019 this commodity group registered the highest share of 7% (6.70%), with the next highest share of 7% (6.52%) during June 2020 and the third highest share of 6% (6.38%) during June 2018.

#### Figure 5: Iron and Steel (ITC HS CODE - 29):

During the month of June 2020 this commodity group registered the maximum share of 8 % in exports of this product category, with the next highest share of 7% during June 2021 and the third highest share of 5% (i.e.5.21%) during June 2022.


#### Figure 6: Vehicles other than railway, tramway(ITC <u>HS CODE -85):</u>

During the month of June 2022 this commodity group registered the maximum share of 5% (i.e. 5.20%), with the next highest share of 5% (i.e. 4.88%) during June 2019 and the third highest share of 4% (i.e. 4.39%) during June 2020.

From the Table 3 & Figure 7, it is observed that Petroleum products (PC Code S6), Pearls Precious, Semi-Precious Stones(PC Code G5) and Drug formulations, biologicals (PC Code H8) were the top 3 PC Codes as far as India's Exports to the world in June 2022 were concerned, accounting for around 48% of the export-value in June 2022. Moreover, it is found that the export performance registered increases from June 2021 to June 2022 for all the 15 PC codes. Notably, Petroleum products(PC Code S6), RMG cotton including accessories (PC Code Q6) and Telecom instruments (PC Code P4) clocked export value growth of over 100% (YoY), with the exception of Iron and steel (PC Code L3) and Organic chemicals (PC Code I3) that showed the YoY decline of 34 % and 5% respectively.

### Figure 8: Share (%) of Top 15 State's Export in June 2022




Table 4 and Figure 8 establish that Gujarat, Maharashtra & Tamil Nadu constituted the top 3 States in India's exports to the world in June 2022, accounting for 59% of the total export-value in June 2022. Almost all the top 15 state showed Year on Year (YoY) % increases. All the other states registered YoY increases in export June 2022, with the exception of Andhra Pradesh and Odisha that showed the YoY decline of 3% and 28% respectively.

Table 4(i) and Figure 8(i) delineate that Jamnagar accounts for more than 53% of the total share of Gujarat state's export to the world, which is unusual, followed by Surat, Devbhumi Dwarka, Kachchhand, Bharucheach with a share of less than 12%.



From the Table 5 and Figure 9, it is observed that Mineral fuels, oils, distillation products, etc. (HS Code 27), Pearls, precious stones, metals, coins, etc. (HS Code 71) and Electrical, electronic equipment (HS Code 85) constituted the top 3 commodity groups (ITC-HS 2 digit codes) in India's imports from the world in June 2022, accounting for about 60% share of the import-value in June 2022. Moreover, almost all the top commodities show YoY increases, the commodity namely"Mineral fuels, oils, distillation products, etc."(HS code 27) and "Ores, slag and ash"(HS code 26) registered more than100% YoY increase. All the other commodities registered YoY increases in Import from June2021 to June 2022, with the exception of Optical, photo, technical, medical, etc. apparatus (HS Code-90) that showed a YoY decline of 13%.

### Figure from 10 to 14: Top 5 Major Commodities of India's Imports from Top 15 ITC-HS Codes during June2018 to June2022




Figure 10: Mineral fuels, oils, distillation products, etc. (ITC HS CODE -27)


#### Figure 12: Electrical, electronic equipment (ITC HS CODE -85)

#### Figure 14: Organic chemicals (ITC HS CODE - 29):





### Figure 16: 15 Major Country of India's Exports in June 2022 (share %)





Table 10 validates the share of 15 Ports in terms of largest contributions to Indian exports. Nava Sheva Sea, SEZ Jamnagar (Reliance) and Sikka are the top 3 ports through which Indian exports took place in June 2022 with total contribution of 32% share of the total export value in June2022. 






