1. **No Refurbishing:** Only new components are allowed. No refurbished or old components are allowed. (Self-declaration to be submitted)
2. **Microsoft Hardware Certification** to be submitted along with bid to confirm hardware for OS compatibility and testing.
3. **Verification of local content:** Declaration to be submitted by the bidder at the time of tender submission indicating the percentage of local content and self-certification that the item offered meets the local content requirement for 'Class-I local supplier' / 'Class-II local supplier', as the case may be. The bidder also must submit the details of all the location(s) at which the local value addition is made.
4. **Experience Criteria:**
 - a. The Bidder as well as the OEM should be a Registered Partnership Firm/LLP/Company/Public Sector undertaking / Govt. Company with operations in India for 5 years or more. - (Certificate of Incorporation / Registration Certificate to be submitted)
 - b. The bidder or its OEM {themselves or through re-seller(s)} should have supplied same product for 80% of bid quantity, i.e.86 PCs, in at least one of the last three financial years before the bid opening date, i.e., 2021-22, 2022-23, 2023-24, to one or more Central / State Govt. Organization / PSUs cumulatively. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year, i.e., completion certificate) to be submitted along with bid in support of quantity supplied in the relevant financial year.

That is, the total PCs delivered to all Central / State Govt. Organization / PSUs should be 86 or more in at least one of the last three financial years.
5. **Warranty and Maintenance:** Comprehensive Warranty should be for 3 years and CAMC (Comprehensive Annual Maintenance Contract) should be for 4 years. So, the total number of years for which support would be provided by the bidder / OEM is 3+4 = 7 years.
6. **Turnover:** Bidder must submit annual turnover as specified in GeM RFP document. Submit documentary evidence.
7. **PAN:** The bidder must submit the copy of their PAN card.
8. **GST Registration Certificate:** The bidder must submit the copy of their GST registration certificate along with acknowledgement of submitted GST returns of the last quarter of financial year.

9. **Income Tax Return:** The bidder should submit copy of acknowledgement of income tax return of the last 3 financial years.
10. **Non-blacklisting:** Declaration to be submitted by the bidder on regarding non-blacklisting / non-suspension from GeM / Central Government / State Government / Agency of Central/State Government of India or any other country in the world / Public Sector Undertaking / any Regulatory Authorities in India or any other country in the world for any kind of fraudulent activities.
11. **MAF:** Bidder must submit valid Bid specific OEM authorization certificate (MAF) along with OEM signatory name, sign, stamp, contact number, email address, on OEM Letter Head technical specification compliance. General Partnership MAF certificate will not be considered for specific bid. OEM should have its own manufacturing facility & should enclose address of manufacturing plant as a proof of OEM along with Factory license of OEM, process of manufacturing in the Factory and list of plant & machinery. The OEM Declaration w.r.t. End of Life warranty for items for better warranty service and OEM Declaration for no refurbish component will be used in products must be submitted.
12. **Genuine Softwares:** Bidder should submit valid OEM Declaration for genuine Windows operating systems Windows11 Professional from OEM factory preloaded with Computers.
13. **Delivery:**
 - a. Bidder has to ensure the delivery & installation of all the items within 60 working days after receipt of the purchase order.
 - b. In case of delay in delivery beyond the period mentioned, a penalty of 1% for each week of the total cost of undelivered quantities for first two weeks of delay and 1.5% for each week for delay beyond two weeks subject to a maximum of 5% be levied.
 - c. The bidder must submit during delivery the copies of detailed manuals/brochures with each item/equipment.
 - d. The list of all licences of all softwares supplied with the PCs should be provided by the bidder during time of supply.
14. **Payment** for delivery of Desktop Computers will be released within 60 days only after satisfactory delivery and installation.

For payment of CAMC, **quarterly bills** are to be submitted by bidder after providing satisfactory services for a quarter, which will be paid by DGCIS.
15. **After Sales Service and Support:**
 - a. The OEM / bidder must have a service centre in Kolkata, West Bengal, India for better after sales service. Submit documentary evidence.

- b. The OEM / bidder must have active onsite service support and required to furnish contact details (name, address, mail id & mobile no.) of service executives, details to be furnished on bidder letter head.


16. Regarding financial bid:

- a. During submission of financial bid, the bidder must specify the prices of Desktop Computers separately and **year-wise price** of CAMC for four (04) years separately.
 - b. The bid price must be inclusive of all components, GST, Packing, Freight, Unloading, Installation etc.
- 17. Relaxations** related to MSME and Start-ups will be considered by DGCIS, provided relevant valid certificates of MSME and / or Start-up is submitted by the bidder.
- 18.** DGCI&S, Kolkata, reserves the right to cancel the bid at any time without assigning any reasons thereof (without prior notification).
- 19.** The successful bidder has to submit a **Performance Guarantee of 3% of the total contract value** (value of Desktop Computers + value of CAMC for four years).

ADDITIONAL CONDITIONS / REQUIREMENTS

1. Furnishing fake information on all or any requisite documents may lead to rejection of the bid and blacklisting.
2. During warranty period, any emergency call must be attended by the bidder / OEM within 24 hours.

The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. 2	Operating System	<ol style="list-style-type: none"> There is no requirement that the OEM of the desktop systems should be a device partner of Microsoft and holding a Microsoft Authorization Form (MAF) from the software provider. Microsoft OS may be sourced directly from Microsoft by OEMs holding device partner status, and those not holding device partner status may source from authorized distributors, i.e., Ingram/Reddington and their authorized channel partners. Buyers may ensure that MAF shall not be made a mandatory requirement in bids. Further there will be 98% uptime warranty during CMC period on 24 (hrs) X 7 (days) X 365 (days) basis, with penalty, to extend CMC period by double the downtime period.

2. CMC charges to be indicated as percentage of cost of equipment quoted for each year after the warranty period.

The prices also include cost of spares and damaged parts. Purchaser does not have any liability, whatsoever, over and above the cost of CMC. It also includes for arranging hand tools & tackles, special tools etc. required to carry out the work.
