In this present edition in-depth information on shipping movement Statistics is provided. The publication came into being since April, 1965. The current issue of the publication titled as "Statistics of Foreign and Coastal Cargo Movement of India" attempts to update the knowledge in the area of Internal Trade.

In this publication data on 'entry' and 'clearance' of ships with Cargo and without Cargo at different ports in India are provided using various tables and graphs. Receiving data from Customs zone, Maritime Boards and Ports had been a challenge. This publication, thus, could provide data on only 24 Ports, including both 'Major Ports' and 'Non-major Ports' out of a total of 77 such Indian Ports handling Cargoes.

For future, efforts are on to increase the coverage of data for this publication. I am hopeful that our efforts will prove immensely beneficial to our users, regular readers and subscribers.

However, comments and suggestions for improvement of forthcoming issues are welcome.

SUMMARY

This Publication contains Statistics on arrival and departure of ships with Cargo or as Ballast. The statistics of shipping on the foreign and coastal trade of India are based on the returns received from the Sea Ports, Customs Authorities and Maritime Boards of India.

Vessels involved in foreign trade are recorded as 'entry' on the voyages inwards at the first Indian port at which cargoes are discharged and as 'clearance' on the voyages outward at the last Indian port at whichcargo is loaded. In other words, the inward foreign voyage ends at the first Indian port touched for discharging cargo. Similarly, the outward foreign voyage begins with departure from a port in India after loading cargo for some destination abroad without touching other Indian ports. However, if an Indian port is only a port of call in a voyage from or to a foreign port beyond India, the entry or clearance will be recorded as foreign trade

Inward voyages of a ship at a port from another Indian port and outward voyage to another Indian port is recorded as 'entry' and 'clearance' in coasting trade. Vessels clearing to or entering from a non-registered Indian port are also recorded in the coasting trade unless the port is only a port of call in a voyage from or to a foreign port.

The data regarding ships are provided in terms of number and tonnage of vessels. The tonnage is the net registered tonnage, i.e., the entire capacity of the vessels in terms of hundred cubic feet (i.e. gross tonnage) minus certain deduction for the space occupied by engines, crew's quarters etc.

HIGHLIGHT

Foreign Vessels Entered with Cargo

Number (No.) of vessels (including the cases of repeated voyages) which Entered with Cargo in Foreign trade was 5839. Out of this, No. of STV and SV vessels were 3150 and 2689 respectively.

Net Registered Tonnage (NRT) of vessels (including the cases of repeated voyages) which Entered with Cargo in Foreign trade was 128944294. Out of this, NRT of STV and SV vessels were 74471798 and 54472496 respectively.

KOLKATTA Zone (1424) was Top and PUNE Zone (28) was lowest in terms of numbers of vessels Entered with Cargo in the country.

Highest NRT of 31000050 entered in BHUBANESWAR Zone which was 24.04% of total entered NRT in the country.

Nationality wise, PANAMA was top in terms of number of vessels Entered with Cargo (1174) while LIBERIA had the highest NRT of vessels Entered with Cargo (29797896).

Country wise, SOUTH KOREA was in top position, both in terms of No. and NRT of vessels Entered with Cargo, with figures of 2011 and 31926507 respectively.

Foreign Vessels Entered as ballast

Number (No.) of vessels (including the cases of repeated voyages) which Entered as Ballast in Foreign trade was 493. Out of this, No. of STV and SV vessels were 309 and 184 respectively.

Net Registered Tonnage (NRT) of vessels (including the cases of repeated voyages) which Entered as Ballast in Foreign trade was 7312063. Out of this, NRT of STV and SV vessels were 3921690 and 3390373 respectively.

VISAKHAPATNAM Zone 206 was Top and TIRUCHIRAPALLI Zone 02 was lowest in terms of numbers of vessels Entered as Ballast in the country. In Ahmedabad Zone no vessel entered as ballast.

Highest NRT of 2456916 entered in VISAKHAPATNAM Zone which was 33.60% of total Entered NRT in the country.

Nationality wise, PANAMA was top both in terms of No. and NRT of vessels Entered as Ballast, with figures of 163 and 1930618 respectively.

Country wise, SOUTH KOREA was the top both in terms of No. and NRT of vessels Entered as Ballast, with figures of 206 and 2359578 respectively.

Foreign Vessels Cleared with Cargo

Number (No.) of vessels (including the cases of repeated voyages) which Cleared with Cargo in Foreign trade was 2443. Out of this, No. of STV and SV vessels were 1283 and 1160 respectively.

Net Registered Tonnage (NRT) of vessels (including the cases of repeated voyages) which Cleared with Cargo in Foreign trade was 42092973. Out of this, NRT of STV and SV vessels were 16239918 and 25853055 respectively.

TIRUCHIRAPALLI Zone (698) was Top and MUMBAI Zone (09) was lowest in terms of number of vessels Cleared with cargo.

Highest NRT of 13557681 was Cleared in AHMEDABAD Zone which was 32.21% of total Cleared NRT with cargo.

Nationality wise, LIBERIA was the highest, both in terms of No. and NRT of vessels Cleared with cargo, with figures of 482 and 8994462 respectively.

Country wise SOUTH KOREA had the highest Number of vessels Cleared with cargo (405), while CHINA had the highest NRT of vessels Cleared with cargo (8146797).

Foreign Vessels Cleared as ballast

Number (No.) of vessels (including the cases of repeated voyages) which Cleared as Ballast in Foreign trade was 899. Out of this, No. of STV and SV vessels were 454 and 445 respectively.

Net Registered Tonnage (NRT) of vessels (including the cases of repeated voyages) which Cleared as Ballast in Foreign trade was 23977377. Out of this, NRT of STV and SV vessels were 14394838 and 9582539 respectively.

BANGALORE Zone (434) was Top and TIRUCHIRAPALLI Zone (02) was lowest in terms of Numbers of vessels Cleared as Ballast in country. In Mumbai Zone no vessel was cleared as ballast.

Highest NRT of 10746736 was cleared in VISAKHAPATNAM Zone which was 44.82% of total Cleared NRT as ballast in the country.

Nationality wise, PANAMA had highest number of vessels Cleared as Ballast (177) while LIBERIA had the highest NRT of vessels Cleared as Ballast (6444244).

Country wise, UAE was the highest both in terms of No. and NRT of vessels Cleared as Ballast, with figures of 215 and 5460016 respectively.

Coastal Vessels Entered with Cargo

Number (No.) of vessels (including the cases of repeated voyages) which Entered with Cargo in Coastal trade was 4771. Out of this, No. of STV and SV vessels were 2728 and 2043, respectively.

Net Registered Tonnage (NRT) of vessels (including the cases of repeated voyages) which Entered with Cargo in Coastal trade was 57149583. Out of this, NRT of STV and SV vessels were 24808095 and 32341488 respectively.

MAGDALLA port occupied the top position in terms of Number of vessels Entered with figure of 1354 with share of 28.38% of total No. of vessels entered with cargo in Costal trade.

PIPAVAV port occupied the top position in terms of NRT of vessels Entered with figure of 13323385 with share of 23.31% of total NRT of vessels entered with cargo in Coastal trade.

Nationality wise, INDIA was the top country both in terms of No. and NRT of vessels Entered with cargo, with figures of 3351 and 26611919 respectively.

Coastal Vessels Entered as Ballast

Number (No.) of vessels (including the cases of repeated voyages) which Entered as Ballast in Coastal trade was 571. Out of this, No. of STV and SV vessels were 369 and 202, respectively.

Net Registered Tonnage (NRT) of vessels (including the cases of repeated voyages) which Entered as Ballast in Coastal trade was 7618173. Out of this, NRT of STV and SV vessels were 5878369 and 1739804 respectively.

MORMUGAO port occupied the top position both in terms of No. and NRT of vessels Entered as Ballast, with figures of 207 and 3592412 respectively.

Nationality wise, INDIA was in top position both in terms of No. and NRT of vessels Entered as Ballast, with figures of 272 and 2363659 respectively. **Coastal Vessels Cleared with Cargo**

Number (No.) of vessels (including the cases of repeated voyages) which Cleared with Cargo in Coastal trade was 3480. Out of this, No. of STV and SV vessels were 1934 and 1546, respectively.

Net Registered Tonnage (NRT) of vessels (including the cases of repeated voyages) which Cleared with Cargo in Coastal trade was 49709853. Out of this, NRT of STV and SV vessels were 26216881 and 23492972 respectively.

PARADIP port occupied first position both in terms of No. and NRT of vessels Cleared with Cargo, with figures of 619 and 14891446 respectively.

Nationality wise, INDIA was the top country both in terms of No. and NRT of vessels Cleared with cargo, with figures of 2260 and 20365814 respectively.

Coastal Vessels Cleared as Ballast


Number (No.) of vessels (including the cases of repeated voyages) which Cleared as Ballast in Coastal trade was 1047. Out of this, No. of STV and SV vessels were 378 and 669 respectively.

Net Registered Tonnage (NRT) of vessels (including the cases of repeated voyages) which Cleared as Ballast in Coastal trade was 12231193. Out of this, NRT of STV and SV vessels were 5258223 and 6972970 respectively.

NEW MANGALORE port occupied first position both in terms of No. and NRT of vessels Cleared as Ballast, with figures of 456 and 5816575 respectively.

Nationality wise, INDIA was the top country both in terms of No. and NRT of vessels Cleared as Ballast, with figures of 614 (58.64%) and 5273494 (43.12%) respectively.





A NOTE ON THE CONCEPTS AND DEFINITION OF THE TERMS

Entry and Clearance of Ships in the Foreign Trade

Vessels in the foreign trade are recorded as entering on the inward voyages at the first Indian port at which cargo are discharged and as clearing on the voyages outward at the last Indian port at which cargo is loaded. In other words, the inward foreign voyage ends at the first Indian port touched for discharging cargo. Similarly, the outward foreign voyage begins with departure from a port in India after loading cargo for some destinationabroad without touching other Indian ports. However, if an Indian port is only a port of calling a voyage from or to a foreign port beyond India, the entry or clearance will be recorded as in foreign trade.

A vessel bringing cargo from more than one foreign port is recorded as entering from the most distant port at which cargo for India was loaded. Conversely, a vessel with cargo departing from India for more than one foreign port is recorded as clearing for the most distant port at which cargo from India would be off-loaded. Vessels in 'Ballast' are recorded with regard to both entry and clearance in the same way as vessels with cargo.

Entry and Clearance of Ships in the Coasting Trade


Inward voyage of a ship at a port from another Indian port and outward voyage to another Indian port is recorded as entry and clearance in coasting trade. Vessels clearing to or entering from a non-registered Indian port are also recorded in the coasting trade unless the port is only a port of call in a voyage from or to a foreign port.

According to the above criteria, if on its inward voyage a ship coming from foreign port has already entered an Indian port to discharge only a part of its cargo and then proceeds to other port in India, its clearance from the first Indian port and entry at the subsequent Indian port(s), are recorded as movement in the coasting trade irrespective of where the ship is loaded with any cargo at the Indian port or not. Conversely, for a vessel on the voyage outwards loaded with part cargo for a foreign port and part for some other port or ports in India, its movement is recorded at the first port of departure as cleared for coasting trade and such vessel is again recorded as cleared for foreign trade at the last Indian port.

Source of Data

The statistics of shipping in the foreign and costal trade of India are based on the returns received from the Indian Ports, Indian Customs Zones and Indian Maritime Boards. Officers & officials from this office sometimes need to visit certain Custom houses as well as Ports to collect the required data and to seek some clarifications on data received. This year data from twenty four ports in India were received.

The data regarding ships are provided in terms of number and tonnage of vessels movement in India. The tonnage is the net registered tonnage i.e. the entire capacity of the vessels in terms of hundred cubic feet (i.e. gross tonnage) minus certain deduction for the space occupied by engines, crew's quarters etc.



In our country, there are 12 major and 200 non-major ports. However, 65 non-major ports out of 200 deal with the cargo along with all the major ports. 12 major ports are under the administrative control of Ministry of Shipping whereas, 200 non-major ports are under the jurisdiction of respective State Maritime Boards/State Government. Out of 77 ports, data have been received from 24 ports names of which are shown in the table below;

Out of the 24 ports reported in the above table, 8 are 'major ports' and 16 are 'non-major ports'.

Since, this publication produces information on the Number and Net Registered Tonnage (NRT) of ships laden with Cargo or as Ballast and not on Commodities being carried in terms of either value or quantity, the under coverage of Data to that extent only has a bearing on under reporting of Numbers are NRT.
