# Visualizing and mapping geographical data Data: India's export by Small Medium Enterprises (SME) during 2023-24




Figure 1 [Heat Map]: Country wise Percentage of SME enterprises during 2023-24

1. Country wise Percentage of Small and Medium Enterprises (SME) enterprises during 2023-24: Figure 1 shows the geographical mapping and visualization of Country wise Percentage of SME enterprises among the total number of enterprises exporting to respective countries during financial year 2023-24 in different percentage categories.

Concentration of countries in terms of percentage of SME enterprises is highest in the range 57 percent to 83 percent across the world.




Figure 3: Country wise Export Percentage of SME enterprises during 2023-24

2. Country wise Export Percentage of Small and Medium Enterprises (SME) enterprises during 2023-24: Figure 3 shows the geographical mapping and visualization of Country wise Percentage of SME's export among the total exports to respective countries during financial year 2023-24.

Concentration of countries in terms of percentage of SME exports is highest in the range 16 percent to 44 percent across the world.

#### 5. Contribution of Major Destination of SME Export from India during 2023-24:

There were 51 countries where around 80% of IECs from SME sector reported to export their SME merchandise during 2023-24 in totality. Top ten such SME destinations were USA, UAE, UK, China, Germany, Saudi Arab, Australia, Canara, Italy and Nepal. Also, there were 33 countries where penetration of export from SME sector in value terms was nearly 80% of total SME export during 2023-24 in cumulative sense. Top ten such valued consumers were USA, UAE, UK, China, Germany, Saudi Arab, Netherland, Italy, Hong Kong and Bangladesh. Also, there is a group of 22 SME export destinations which featured within 80% contributors' club in terms of both (a) number of SME IECs from India and (b) export from SME sector in value terms as described above. They are USA, UAE, UK, China, Germany, Bangladesh, Hong Kong, Netherland, Vietnam, France, Russia, Spain, Belgium, Thailand, Iraq, Turkey, Japan, Indonesia, South Korea, Nigeria, Egypt and Mexico. These group of nations contribute to

around 66% of total SME Export and nearly 21% of overall export against about 30% contribution of total SME sector in overall export in value terms during 2023-24. All relevant Tables are given in Appendix below:
