Highlights

This section provides major observations related to Statistics of the Inland Coasting Trade Consignments of India during the period April 2023 to March 2024 and highlights significant changes from last publication of 2022-2023

- Gujarat(GJ) and Kerala(KL) were top two contributors with shares of 41.39% and 22.88% of total value of outward movement of coastal trade in the year 2023-24 respectively.
- Maharashtra (MH) was top contributor with share of 21.70% of total value of inward movement; Tamil Nadu (TN) came after Maharashtra with the share of 20.07% of total value of inward movement.
- Gujarat (GJ) had maximum share of around 81.69% of total value of internal movement, while Andhra Pradesh (AP) was in the second place with around 6.03% of the same total value.
- During the period April 2023 to March 2024, Andaman & Nicobar Islands had maximum share of 100% of total value (Rs. 58.80 Cr) of outward movement related to the commodity HS 08 i.e. EDIBLE FRUIT & NUTS; PEEL OF CITRUS FRUIT OR MELONS. Again, Tamil Nadu too, had share of 100% of total value (Rs. 58.80 Cr) of inward movement of the same commodity.
- For HS 27 commodity i.e. MINERAL FUELS, MINERAL OILS & PRODUCTS; BITUMINOUS SUBSTANCES; MINERAL WAXES (highest inter-state movement HS 2 digit commodity by value), Gujarat had the maximum share of around 47.73% (Rs. 57316.15 Cr) of total value of outward movement and for inward movement, Tamil Nadu had the maximum share of around 21.69% (Rs. 26052.19Cr) of total value. Gujarat had lion share of around 80.69% (Rs. 2294.60Cr) of total internal movement by value of the commodity HS 27.

- For the commodity HS 73 i.e. ARTICLES OF IRON & STEEL (2nd highest inter-state movement HS 2 digit commodity by value), Kerala had maximum share of around 60.71% (Rs. 11324.45 Cr) of total value of outward movement. For inward and internal movements, Gujarat had the maximum share of 43.76% (Rs. 8164.24 Cr) while Maharashtra had the maximum share of 91.10% (Rs. 1.62 Cr) of their respective total values.
- For HS 84 commodity i.e. NUCLEAR REACTORS, BOILERS, MACHINERY AND MECHANICAL APPLIANCES; PARTS THEREOF, Tamil Nadu had maximum share of around 45.68% (Rs. 82.76 Cr) of total value of outward movement. For inward and internal movements, West Bengal and Tamil Nadu had the maximum shares of around 45.10% (Rs. 81.71 Cr) and 100% (Rs. 3.16 Cr) of the total values respectively.
- It is observed that during the period April 2023 to March 2024 out of all the HS 08 digit products, HS 27101949 commodity i.e. HIGH FLASH HIGH SPEED DIESEL FUEL CONFORMING TO STANDARD IS 16861; lead the inter-state movement table with 32.32% share (Rs. 54219.61 Cr) whereas HS 27101221 i.e. LIGHT NAPHTHA topped the internal movement list with share of 60.53% (Rs. 2169.62 Cr) of their respective total values.
- It is observed that during the financial period April 2023 to March 2024, significant changes have occurred in the values of outward movement of Kerala, inward movement of Goa & Puducherry and internal movement of Maharashtra as compared to their respective values of the previous financial year April 2022 to March 2023.

Chapter One Introduction

This chapter provides a brief background of the inland coasting trade consignments of India during the period April 2023 to March 2024

- 1.1 Coastal Trade Statistics are the data on Trade Consignments of commodities passing from one port to another by sea within India. It does not include external trade i.e. international trade done by India with other foreign countries. The statistics for which are available at the DGCI&S portal (www.dgciskol.nic.in).
- 1.2 The present publication is based on the Daily Trade Returns (DTRs) received from different ports and Custom Authorities on regular basis. Custom authorities capture the information from relevant entry of bills giving details of the inward consignments moving through different ports.
- 1.3 This time Lakshadweep has been covered in this publication however only inward movement has been reported while no outward & internal movements have occurred for this state in this financial period April 2023 to March 2024. All data have been given by the Assistant Commissioner of Customs, Cochin.
- 1.4 For the purpose of Coastal Trade Statistics, Sea ports of India have been grouped under 12 States/UTs viz. (1) Andaman and Nicobar Islands, (2) Andhra Pradesh, (3) Goa, (4) Gujarat, (5) Karnataka, (6) Kerala, (7) Lakshadweep, (8) Maharashtra, (9) Odisha, (10) Puducherry, (11) Tamil Nadu and (12) West Bengal. Information received from these ports along with custom authorities is compiled by Ancillary division of DGCI&S and a report titled "Statistics of the Inland Coasting Trade Consignments of India" is published and uploaded annually on the website of this office for the purposes of various users as well as subscribers.
- **1.5** It is worthwhile to mention that data (DTR) received from different ports are not very regular and this office cannot validate all the data received from the ports.

Chapter Two Concepts and Definitions

This chapter discusses about various concepts and definitions regarding the collection of relevant data and their presentation in various forms of tables and charts for this publication

- 2.1 Business transactions between any two state/UTs or between a state and an UT are covered under inter-state consignments; while business transactions within a state/UT are covered under internal consignments.
- 2.2 Accordingly, data on shipments from one port to another within the same state are treated as internal trade of the concerned state and are taken into account separately in compilation of coastal trade statistics. On the other hand, the movement of consignments from one state to another is treated as inter-state trade. Further, the interstate movements of goods have also been classified on the basis of their individual state of origin and state of destination.
- 2.3 Movement of goods classified on the basis of state of origin is shown as Outward movement of goods from the states and the movement of goods classified on the basis of their destinations is tagged in the tables as Inward movement of goods into those states. The commodities are presented as per the ITC (HS) 08-digit classification as adapted for foreign trade compilation.
- 2.4 From last two years a new initiative has been started. This office receives some data from the port offices which do not contain all the basic transaction data regarding the commodities traded. Values of goods of such transactions have been statistically estimated by DGCI&S office using rest of the data received from other sources rather than discarding such precious information. This helps in increasing the coverage of this publication significantly.
- 2.5 It is, however, admitted that in absence of data from all ports this report is not fully exhaustive.






Figure 3.4VB: Comparison of state-wise inward movement values(in Rs. Crore) between previous FY 2022-2023 & current FY 2023-2024 in bar chart type





Figure 3.4VC: Comparison of state-wise internal movement values(in Rs. Crore) between previous FY 2022-2023 & current FY 2023-2024 in bar format



Statement 4.1V: Top commodities (HS2digit) in inter-state movement of inland

From the statement 4.1V above and figure 4.1V below, it is observed that during the period April 2023 to March 2024, HS 27 commodity i.e. MINERAL FUELS, MINERAL OILS & PRODUCTS; BITUMINOUS SUBSTANCES; MINERAL WAXES had maximum share of around 71.59% of total value of inter-state movement among all the HS 02 digit chapters. If included with no. 2 item i.e. HS 73 (ARTICLES OF IRON & STEEL) and no. 3 product i.e. HS 26 (ORES, SLAG AND ASH) the share amounts to staggering 87.20%. HS 29 (ORGANIC CHEMICALS), HS 72 (IRON & STEEL), HS 25 (SALT; SULPHUR; EARTHS AND STONE; PLASTERING MATERIALS, LIME AND CEMENT), HS 86 (RAILWAY/TRAMWAY LOCOMOTIVES, TRUCKS ETC., EQUIPMENT AND PARTS THEREOF), HS 52 (COTTON), HS 69 (CERAMIC PRODUCTS), HS 28 (INORGANIC CHEMICALS; COMPOUNDS OF PRECIOUS METALS, OR RARE-EARTH METALS, OF RADIO-ACTIVE ELEMENTS OR OF ISOTOPES) held from fourth to tenth rank in this movement in descending order by value. The rest of the products contributed 1.50% share of total inter-state movement. During April 2022 to March 2023 also, the same code HS 27 had held the topmost rank in HS 2 digit inter-state movement table with 63.66% share of the then total value.

Figure 4.1V: Pie chart showing percentage share of top commodities (HS2 digit) in inter-state movement of inland coasting trade in 2023-24




Figure 4.2V: Pie chart showing percentage share of top commodities (HS2 digit) in internal movement of Inland Coasting Trade in the year 2023-24

From the statement 4.2V above and figure 4.2V below, it is observed that during the period April 2023 to March 2024, the commodity HS 27 (MINERAL FUELS, MINERAL OILS & PRODUCTS; BITUMINOUS SUBSTANCES; MINERAL WAXES) was the leading HS2 digit item with around 79.33% share, HS 25 (SALT; SULPHUR; EARTHS AND STONE; PLASTERING MATERIALS, LIME AND CEMENT) stood 2nd bearing share of 16.96% and HS 28 (INORGANIC CHEMICALS; COMPOUNDS OF PRECIOUS METALS, OR RARE-EARTH METALS, OF RADIO-ACTIVE ELEMENTS OR OF ISOTOPES.) held 3rd place possessing 1.68% share of total value of internal movement. Hence these top three commodities along with the 4th one, HS 29 (ORGANIC CHEMICALS) held near about 98.69% of the same total value. All commodities have been considered.

From the above statement and figure 4.3V it is observed that during our year of focus, HS 27101949 (HIGH FLASH HIGH SPEED DIESEL FUEL CONFORMING TO STANDARD IS 16861) topped the inter-state movement table among all the ITC HS 8 digit commodities with 32.32% share followed by HS 27101943 (LIGHT DIESEL OIL CONFORMING TO STANDARD IS 15770) with 14.05% share and HS 73102910 (TIN PLATE CONTAINERS) acquired third rank bearing 7.06% share of the total value of inter-state movement. Therefore the top three commodities along with no. 4 i.e. HS 27101242 (E 20 FUEL CONFORMING TO STANDARD IS 17021) were found to contribute 60.47% share of this movement. In the previous publication in the focused period April 2022 to March 2023 also, the same HS 8 digit commodity i.e. HS 27101949 (HIGH FLASH HIGH SPEED DIESEL FUEL CONFORMING TO STANDARD IS 16861) had aced the inter-state movement with only 19.38% share of the total value.




Figure 4.4V: Pie chart showing percentage share of top commodities (HS8 digit) in internal movement of inland coasting trade in the financial year 2023-24

From the above statement and figure 4.4V it is observed that during this publication's considered financial year April 2023 to March 2024, HS 27101221 (LIGHT NAPHTHA) appeared at the zenith of internal movement out of all the HS 8 digit commodities holding 60.53% share; second with only 16.90% share was HS 25010010 (COMMON SALT(INCL. IODISED SALT)); and HS 27101949 (HIGH FLASH HIGH SPEED DIESEL FUEL CONFORMING TO STANDARD IS 16861) having portion of 7.25% came third. Dragging along at 4th place was HS 27011920 (STEAM COAL) with 4.88%. The above mentioned four toppers together bore 89.57% chunk of total value of internal movement from April 2023 to March 2024.
