

Review of India's Merchandise Export and Import with respect to Pakistan

A review of EXIM Data (Merchandise Export and Import) of Financial Years (FY) [2022-23 and 2023-24] indicates that, Pakistan has been a very minor trading partner for India. Out of India's total exports of USD 451070 million in FY 2022-23, export to Pakistan from India was merely 0.14%. In FY 2023-24 India's total exports was USD 437072 million of which only 0.27% (USD 1189 million) was routed to Pakistan. Likewise, import from Pakistan to India was even smaller than export with 0.003% of India's overall import sourced from Pakistan for FY 2022-23 while that for FY 2023-24 it was only 0.0004%. India has evidently maintained a surplus balance of trade with Pakistan for both these financial years.

Export to Pakistan from India

Additionally, in FY 2024-25 as per provisional estimates, India' export to Pakistan is reportedly USD 558 million and import only USD 0.46 million with a resultant Trade Surplus of USD 557.32 million.

- Drugs and Pharmaceuticals Group have consistently dominated our exports to Pakistan with exports worth USD 208 million recorded in FY 2024-25 accounting for 37.3% of all exports to Pakistan during the said year.
- The top three commodity groups [comprising Drugs and Pharmaceuticals, Organic & Inorganic Chemicals and Engineering Goods] accounted for nearly 65% of all exports during FY 2024-25.
- In FY 2023-24 exports of Petroleum Products was recorded at USD 688 million which in FY 2024-25 has significantly declined to only USD 12 million. Similarly, exports of Oil meals were recorded on the higher side to the tune of USD 43 million in FY 2023-24 which has now dipped to USD 11 million in FY 2024-25.
- In FY 2024-25 India had exported to Pakistan USD 7.22 million worth of Fruits and Vegetables; USD 6.77 million worth of Cereal Preparations and Miscellaneous Processed Item; USD 4.03 million worth of Plastic and Linoleum; USD 3.15 million worth of Oil Seeds, etc. all these have been recorded under "Others" in Table 2 above.

The Principal Commodity Groups which were exported majorly in FY 2024-25 were Drug Formulations & Biologicals, Sugar, Bulk Drugs & Drug Intermediaries and Residual Chemical & Allied Products with respective shares of 24.29%, 21.63%, 12.35% & 9.19% in India's total exports to Pakistan in the said year.

- The top three export categories—Drug Formulations & Biologicals (H8), Sugar (C4), and Bulk Drugs & Drug Intermediates (H5 have accounted for approximately 58% of the total export value earned by way of exports to Pakistan in FY 2024-25. This underscores the critical significance of pharmaceutical sector in India's export basket w.r.t. Pakistan. Both PC Groups H8 and H5 have exhibited robust performance over the past three financial years.
- As regards Sugar (C4) which was the leading commodity exported in FY 2022-23 with exports worth USD 174 million, there was a dip in exports in FY 2023-24 to the tune of only USD 80 million followed by a turn-around in FY 2024-25 with exports peaking to USD 121 million.
- Residual Chemical and Allied Products (I7) and Organic Chemicals (I3) together constituted over 14% to the total exports, with export values of USD 51 million and USD 29million respectively recorded for FY 2024-25. These commodity groups have shown consistent growth in export values indicating a strong demand for specialized chemical products from Pakistan's end.
- **Emerging Sectors:** Auto Components/Parts (M3) has seen a dramatic rise in export value from only USD 0.50 million in FY 2022-23 to about USD 30million in FY 2024-25.

A review of UN Comtrade Database for Calendar Year (CY) 2024 indicates that Pakistan has imported goods worth USD 56.48 billion from the entire world out of which at ITC HS-6 level 100% imports for goods with HSN 293949 and 300460 have been sourced from India with respective values of USD 2.27 million and USD 0.32 million. There are also identified 13 other HS-6 level commodities for which Pakistan's imports from India is significantly high i.e. more than 75% of total imports of those HSNs had been routed/sourced from India in CY 2024.

- Sea ports have consistently been playing the dominant role in handling export related cargoes to Pakistan; followed by Air Cargo mode.
- Exports through ICD mode rose to USD 72.97 million in FY 2024-25 from USD 42.67 million USD in FY 2023-24, showing increased inland logistics activity. Additionally, exports through SEZ mode have increased steadily over the years.

For FY 2024-25, Nhava Sheva Sea was the top Port through which most of the exports to Pakistan took place. This Port's share in total exports to Pakistan in FY 2024-25 stood at 31.1%. Mundra SEZ and Hyderabad Airport occupied second and third places with shares of 21.4% and 11.7% respectively.

- **Nhava Sheva Sea** located near Mumbai, is India's largest container port and a critical gateway for maritime trade. **Mundra**, in Gujarat, is the next in terms of handling cargo for export to Pakistan, benefiting from its proximity to the country. Together, these two ports have accounted for nearly 53% of total exports to Pakistan in FY 2024-25.
- Hyderabad Airport, ranking third and contributing about USD 65 million (11.7%) exports, is complemented by ICD Hyderabad with USD 23million (4.2%) exports. Collectively,
 Hyderabad has reportedly handled 15.9% of exports to Pakistan in FY 2024-25, highlighting its growing importance as a logistics hub.
- Air cargo ports, including Mumbai Air (5.9%) and Delhi Air (3.0%), contributed 8.9% of exports, focusing on export of time-sensitive, high-value goods. Special Economic Zones (SEZs) such as Serum Bio Pharm Park SEZ Pune (2.7%) and Vaxenic India Pvt. Ltd. SEZ Sham (1.4%) have a composite total of 4.1% in FY 2024-25.
- ICD Hosur (3.1%) and Kattupalli Port / Tiruvallur (2.6%), both in Tamil Nadu, indicate Southern India's significant share in export activity to Pakistan. The sizable share of Other Ports (12.9%) suggests a diverse network of smaller ports and ICDs handling niche or localized exports.

Import from Pakistan by India

India's imports from Pakistan have steeply declined from USD 20.36 million in FY 2022-23 to USD 2.63 million in FY 2023-24 and to only USD 0.46 million in FY 2024-25. Additionally, as per UN Comtrade Database, in CY 2024 Pakistan had reportedly exported USD 32.4 billion worth of goods to the World with USA and China as top export destinations.

- In terms of Quick Estimates Commodity Groups Classification, the major imported commodity groups in FY 2024-25 are Fruits and Vegetables (USD 0.08 million), Medicinal and Pharmaceutical Products (USD 0.05 million) and Textile Yarn Fabric, Madeup Articles (USD 0.03 million). Import values of both Fruits and Vegetables and Medicinal and Pharmaceutical Products have declined over the years during FY 2022-23 to FY 2024-25.
- Contrary to FY 2022-23 and 2023-24 no imports have been recorded in FY 2024-25 for QE commodity groups Metalliferous Ores and Other Minerals and Organic and Inorganic Chemicals.
- In FY 2022-23 when imports from Pakistan were to the tune of USD 20.36 million, import of Transport Equipment worth USD 17.20 million was the key component. Subsequently in the following years import of Transport Equipment by India from Pakistan stands at NIL.

- Imports of specific HSNs from PC groups namely Spices, Fresh fruits, Ayush and herbal products and Cotton fabrics, made-ups, etc. constituted bulk 75% of our imports from Pakistan in the immediate previous FY 2024-25.
- Additionally, imports from Pakistan have been majorly routed through Nhava Sheva Sea Port and available data for FY 2024-25 indicates that import transactions through Nhava Sheva Sea Port have been executed in all the 12 months. For other ports such as Mundra ICD Bangalore, SEZ Kandla and ICD Garhiharsaru (Haryana) transactions have been recorded only in any one month during FY 2024-25.
- The following **Table 9** indicates that bulk of the imports from Pakistan is routed into India through Sea Ports. In FY 2024-25 imports were routed through Sea port, ICD port and SEZ, contrary to that in the previous FY (2023-24) imports were additionally routed through Airport and prior to that in FY 2022-23 imports were also routed through land mode. India's imports from Pakistan have declined steeply and the multiple modes of import have also reduced in number.

From the above table it can be deduced that of USD 0.42 million, goods of varying categories worth USD 0.05 million have COO status as Pakistan and COC status is some other nation. Further, out of the USD 0.42 million trade record, goods worth USD 0.30 million with COO as Afghanistan have been routed through COC Pakistan.

As regards commodities recorded as **PC Group-Other Commodities** with COO as Pakistan, a total of USD 6.94 million worth of goods have been sourced from some other nation i.e. COC is some other nation and the same is recorded at Table 11 above. Table 11 above further indicates that goods worth only USD 0.02 million with COO as Afghanistan have been routed through COC Pakistan.
